Waiver and Release of Liability—Please Read Carefully

(a) risks and dangers exist in my participation as a volunteer at the Pet Alliance of Greater Orlando; (b) my participation as a volunteer at the Pet Alliance of Greater Orlando, interaction with any animals, and/or use of any equipment provided by the Pet Alliance of Greater Orlando, may result in injury or illness including, but not limited to bodily injury, bites, scratches, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of Pet Alliance of Greater Orlando. I hereby assume all risks and dangers and all responsibilities for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, or employees of the Pet Alliance of Greater Orlando or by another other person.

I, _____ (print name) on behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify the Pet Alliance of Greater Orlando and its owners, agents, officers, and employees from any and all claims, suits or- causes of action for bodily injury, property damage, wrongful death, loss of services or- otherwise which may arise in part or in whole out of any activity that occurs while I am on the premises of the Pet Alliance of Greater Orlando as a volunteer, or that arises in part or in whole out of anything that occurs during the performance of my job as a volunteer, my interaction with any animals, or my use of any equipment or my participation in any manner whatsoever as a volunteer for the Pet Alliance of Greater Orlando. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the Pet Alliance of Greater Orlando and its owners, agents, officers or employees. I hereby acquit, release, exonerate, and discharge the Pet Alliance of Greater Orlando, its officers, directors, owners, employees, their successors, legal representatives and assigns from any amount of damages, including but not limited to medical expense, lost wages, pain and suffering and disability resulting directly or indirectly from bodily injury, personal injury, or property damage, that may be or is caused, suffered or incurred by me as a volunteer for the Pet Alliance of Greater Orlando.

I HAVE READ THE ABOVE WAIVER OR RELEASE AND BY SIGNING IT AGREE IT IS MY INTENTION TO EXEMPT AND RELIEVE THE PET ALLIANCE OF GREATER ORLANDO FROM LIABILITY FOR PERSONAL LIABILITY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE OF ACTION.
